


PULP INPUT PRICES

Q2 2024 NBSK average prices¹ in CAD increased 19.5% and BEK average prices¹ climbed 21.6% from Q1 2024.

Q2 2024 NBSK average prices¹ in CAD grew 14.5% and BEK average prices¹ rose 18.4% year-over-year.

Based on industry forecasts for 2024, pulp prices are expected to remain elevated over the course of the year.





(CAD/USD exchange rate averaged 1.37 in Q2 2024 compared to 1.34 in Q2 2023)

- Production rates at plan, while North American market remains highly utilized
- Upcoming paper machine start-up on track for Q4 2024

- Ratified new five-year collective agreement at Crabtree facility







FACIAL MARKET UPDATE

- Grocery facial category has been reset following Kleenex exit
- Gaining fair share of the market with industry leader Scotties recently achieving 42.8% of total facial tissue sales in Canada
- Both legacy and new facial lines operating above plan
- Launched Scotties' pocket packs and new Ultra Soft and Ultra Soft with Lotion SKUs to help drive share gains
- Strong marketing support with House and Home Design series and Scotties' sponsorship of Canada's Got Talent television show
- Continued increased investments in the Scotties brand










- Released unique Cashmere Ultraluxe Bathroom Guide to set the standard for restaurant bathroom excellence



AFH SEGMENT

- Robust EBITDA results in Q2 2024 improved over Q2 2023 and Q1 2024
- Sales volume increased in Q2 2024 from same period in 2023 and rose sequentially due to seasonality
- AFH converting asset performance supporting growth in volume
- Sherbrooke start-up will provide internal paper to reduce external requirements
- Sales volume tracking well despite uncertain economic environment

Increase primarily due to the following factors:

- · Higher sales volume
- · Favourable sales mix
- Higher selling prices
- Lower pulp prices

Partially offset by:

- · Higher manufacturing overhead
- Increased warehousing expenses
- Higher SG&A costs

Decrease primarily due to:

- · Increased manufacturing overhead
- Higher pulp prices

Partially offset by:

- Higher selling prices
- Increased sales volume
- Reduced freight, warehousing, SG&A and marketing expenses

- Net debt increased \$22.7 million on a sequential basis mainly due to the Sherbrooke Expansion Project
- Leverage remained stable sequentially at 4.0x as higher net debt was offset by greater LTM Adjusted EBITDA



CAPITAL EXPENDITURES



- Q2 2024 CAPEX totaled \$50.4 million, including \$46.2 million related to Sherbrooke Expansion Project
- Year-to-date CAPEX stood at \$100.4 million
- Anticipating \$200-\$220 million in total CAPEX for 2024
